16. AWARD OF CONSTRUCTION MANAGEMENT AND INSPECTION SERVICES FOR THE WANKET TANK REFURBISHMENT AND CONVERION, RECYCLED WATER PIPELINE, RECYCLED WATER VALVE REPLACEMENT, AND MOONLIGHT BEACH PUMP STATION MODIFICATION PROJECT

### DISCUSSION

# Monthly Treatment Plant Performance and Evaluation

Wastewater treatment for the San Elijo Joint Powers Authority (SEJPA) met all National Pollutant Discharge Elimination System (NPDES) ocean effluent limitation requirements for the month of August 2023. The primary indicators of treatment performance include the removal of Total Suspended Solids (TSS) and Carbonaceous Biochemical Oxygen Demand (CBOD). The SEJPA is required to remove a minimum of 85 percent of the TSS and CBOD from the wastewater. Treatment levels for **TSS** and **CBOD** were **99.2** and **99.0** percent removal, respectively, during the month of August.





Figure 1 (below) shows historic treatment performance trends for the removal of TSS and CBOD over the last 13 months compared to the permit minimum removal requirement of 85%.





FIGURE 3: TREATED EFFLUENT FLOWS REMOVAL OF CBOD

Figures 2 and 3 (below) show historic influent vs effluent TSS and CBOD concentration fluctuations in the strength of the wastewater being received and discharged by the SEJPA.

### Member Agency Flows

Table 1 (below) presents the influent and effluent flows for the month of August. Average daily influent flows were recorded for each Member Agency. Total effluent flow was calculated for the San Elijo Water Campus. Approximately 62% of the influent flow was diverted for recycled water use in August.



Also shown in Figure 4 is the total wastewater treatment capacity of the water campus, 5.25 mgd, of which each Member Agency has the right to 2.2 mgd, Rancho Santa Fe Community Service District leases 0.25 mgd, and the City of Del Mar leases 0.60 mgd.

### **DISCUSSION**


### Recycled Water Production

For the month of August 2023, recycled water demand was 178.9 acre-feet (AF), which was met using 178.4 AF of recycled water and supplemented with 0.5 AF of potable water. August demand was 26.8% below budget expectations of 235 AF due to the tropical storm that produced rain in the area on August 20. SEJPA recycled water demand relies heavily on outdoor irrigation water and rainfall can impact demand.


Figure 1 (attached) provides a graphical view of annual recycled water demand spanning the last 10 fiscal years, with the overlay of annual rainfall. Since the recycled water program primarily serves outdoor irrigation, annual demand is reduced during wet periods and increases during times of drought. Figure 2 (attached) shows the monthly recycled water demand for each August for the last ten years to provide a year-over-year comparison. Figure 3 (attached) compares budget versus actual recycled water sales for FY 2023-24.



SUBJECT: WANKET TANK REFURBISHMENT, PIPELINE, AND RECYCLED WATER VALVE REPLACEMENT – REJECT BID AND REVISED STRATEGY FOR PROJECT DELIVERY

#### RECOMMENDATION

- 2. Discuss and take other action as appropriate.

#### BACKGROUND

In 2022, SEJPA acquired rights to the existing 3-million-gallon Wanket Tank located adjacent to the Encinitas Ranch Golf Course, which had been taken out of service approximately 10 years ago. Plans were developed to refurbish the concrete tank and build a pipeline to connect the tank to SEJPA's existing distribution system. Increasing water storage within the distribution system will relieve operational stress, improve system reliability, and increase service capacity. SEJPA has secured State and Federal grants to partially fund the tank refurbishment and connecting pipeline. In addition, as part of its regular asset management program, 35 existing isolation valves within the distribution system that are at the end of their service life (20+ years of service) have been identified for replacement.

The project was packaged with three work components, the tank refurbishment, the connecting pipeline, and replacement of existing distribution system valves. The strategy of combining these projects into one construction contract intended to leverage common public works labor and purchasing power, with the expectation that a larger scope would increase bidder competition and yield lower overall costs. The Engineer's Estimate and SEJPA budget for these combined projects was \$3 million.

### DISCUSSION

In July 2023, SEJPA publicly noticed and advertised a Request for Bids for The Wanket Tank Refurbishment, Recycled Water Pipeline, and Recycled Water Valve Replacement Project on

PlanetBids, its online bidding portal. A total of 60 entities accessed the bidding documents via PlanetBids during the bid period including 18 contractors registered as "prime" bidders; however, only a single bid was received. The single bidder, Pacific Hydrotech, Inc. submitted a bid of \$4,612,600, which exceeded the project budget by approximately \$1.6 million.

To understand the limited bidder response, SEJPA staff contacted non-bidders and met with the single bidder to assess the reason for the limited response to this solicitation. Concerns included disparate project scopes, stipulated requirements for working within the golf course, and logistics of working within public rights of way. SEJPA conferred with its consultant engineer and construction manager to obtain opinions on the scope, project phasing, and cost implications.

Based on the input received from the construction market and our consultants, it is now believed that advertising these scopes as separate construction packages focused on discrete work elements will yield more bidder interest. The pipeline scope can be rebid immediately to minimize delays to the capital program with the intent of completing the work within the golf course before summer 2024. The Wanket Tank refurbishment will be further evaluated through a value engineering exercise and rebid in early 2024.

SEJPA will reassess the recycled water valve replacement scope and conduct outreach to small, local contractors before rebidding. It is anticipated that smaller bid packages with valves grouped by location will be more attractive to local contractors. Prioritizing the most critical valves and phasing the replacement of 35 valves may improve bidder interest and reduce burden on SEJPA staff to administer the construction contracts.

In light of this assessment, staff is recommending the Board reject all bids and readvertise the projects as set forth above in future publicly noticed bid packages. Public Contract Code Section 20783 allows the Board, in its discretion, to reject any bids and readvertise.

# FINANCIAL IMPACT

There is no fiscal impact associated with the recommended Board action.

# RECOMMENDATION

It is therefore recommended that the Board of Directors:

- 1. Reject all bids and authorize SEJPA staff to pursue revised strategy for project delivery; and
- 2. Discuss and take other action as appropriate.

SUBJECT: AIR AND WATER REGULATORY INFORMATION UPDATE

### RECOMMENDATION

No action required. This memorandum is submitted for information only.

### BACKGROUND

San Elijo Joint Powers Authority operates and maintains a variety of wastewater, stormwater, and recycled water infrastructure that requires compliance with 34 permits from 6 regulating agencies. Staff monitor the implications of emerging and anticipated future regulations on the sustainable operation of SEJPA's facilities. Understanding these regulatory trends allows SEJPA to maintain compliance with permits, develop adaptive operating strategies, and make informed capital program decisions to ensure alignment with future environmental standards.

### DISCUSSION

Staff will brief the Board on significant regulatory trends including:

- Per- and Polyflouroalkyl Substances (PFAS), a large, complex group of synthetic chemicals that will soon be regulated in drinking water;
- Potable reuse regulations including adopted rules for indirect potable reuse and imminent rules for direct potable reuse; and
- Air emission regulations that govern use of biogas.
