12. NORTH SAN DIEGO COUNTY COOPERATIVE DEMINERALIZATION PROJECT

The General Manager Michael Thornton stated that in an effort to maximize the regional benefit of the SEJPA's planned recycled water demineralization project, the SEJPA has

partnered with the Olivenhain Municipal Water District (OMWD) and the San Elijo Lagoon Conservancy to create the North San Diego County Cooperative Demineralization Project (Project). The General Manager presented a PowerPoint presentation to highlight the project elements and community benefits. The Project includes a study of potential brackish groundwater demineralization by OMWD for increasing local potable water supplies, water quality and quantity monitoring in the San Elijo Lagoon by the Lagoon Conservancy, the construction of a recycled water demineralization facility by the SEJPA for improving water quality and increasing production capabilities, and the design and construction of urban runoff diversion structures by the City of Solana Beach and the SEJPA. The urban runoff diversions structures will redirect low flow storm water and urban runoff from the San Elijo Lagoon and local beaches and send the flow to the San Elijo Water Reclamation Facility for treatment and reuse and/or disposal. OMWD General Manager Kim Thorner gave a brief presentation on OMWD's component of this project, which is the feasibility evaluation of treating brackish ground water for potable water supply. One of the common elements between the projects is that the brine from the OMWD treatment facility could potentially be treated and disposed of through existing infrastructure owned by the SEJPA. providing operational cost advantages to both agencies. This project has been selected by the San Diego Integrated Regional Water Management (IRWM) group for \$1.05 million in grant funding. Final approval of the grant award is expected summer 2011.

13. REC-1 OCEAN DISCHARGE COMPLIANCE UPDATE

General Manager Michael Thornton stated that the California Regional Water Quality Control Board (Regional Board) recently established new requirements for the SEJPA's discharge of treated municipal wastewater from the San Elijo Water Reclamation Facility to the San Elijo Ocean Outfall (SEOO). The Regional Board established a mandated compliance schedule for meeting these new receiving water standards. Task 1 of the compliance schedule was to prepare and submit a proposed work plan that outlines the approach, necessary infrastructure, and the construction schedule of new infrastructure needed for ensuring compliance with the new standards. The work plan was completed by the SEJPA in February 2011 and submitted to the Regional Board on March 2, 2011. A copy of the final work plan is on file at the SEJPA office.

The submitted work plan provided a detailed review and analysis of more than 4,600 water samples taken near the outfall over a six year period. The conclusion of the analysis is that the current treatment and ocean discharge systems provide compliance to the new water quality standards. Therefore, the SEJPA is recommending no new ocean treatment is required and has requested that Tasks 2-7 be eliminated from the NPDES permit. In addition, the SEJPA will continue its pursuits of recycling wastewater as a preferred alternative to ocean disposal.

This was an informational report not requiring Board action.

14. QUARTERLY UPDATE - RECYCLED WATER DISCUSSIONS BETWEEN THE SAN ELIJO JOINT POWERS AUTHORITY (SEJPA) AND THE SANTA FE IRRIGATION DISTRICT (SFID)

General Manager Michael Thornton gave the Board of Directors a quarterly update on the progress of negotiating new recycled water agreements with the SEJPA's existing the water purveyors; Santa Fe Irrigation District (SFID), San Dieguito Water District (SDWD), and the City of Del mar.

The General Manager reported that the SFID and SEJPA staff met twice within the quarter. Discussions focused on whether to amend the existing agreement or replace the agreement with an entirely new agreement. Also, SFID has awarded a construction contract to expand the existing distribution system to serve the lower San Dieguito Park property and some high-use estate properties in the area. The new use is expected to begin in late 2011 and may ultimately serve an additional 50 to 80 acrefeet per year of recycled water.

The SDWD and SEJPA staff met twice during the quarter. Discussions focused on ways to reduce the cost of recycled water in the service area without reducing the current sales revenue that the SEJPA depends on to operate the system. The General Manager stated that use within the SDWD service area has decreased substantially in the past two years from conservation efforts.

The 22nd Agricultural District, City of Del Mar, met once during the quarter to discuss expanding recycled water use to serve additional irrigation demands at the Del Mar Fairgrounds. The SEJPA has provided technical assistance to the District for assessing the feasibility for using recycled water in cooling towers at the fairgrounds. The General Manager stated the next step in the process is obtaining County Department of Environmental Health approval for converting the cooling towers to recycled water and for the proposed expansion of the fairground's irrigation system.

This was an informational report not requiring Board action.

15. <u>JOINT LOBBYING AND COST SHARING BETWEEN THE MEMBERS OF THE</u> NORTH SAN DIEGO COUNTY REGIONAL RECYCLED WATER PROJECT

General Manager Michael Thornton stated that at the February 2011 meeting of the SEJPA Board of Directors, staff presented the concept of seeking federal funding for the North San Diego County Regional Recycled Water Project (Project). The Project seeks to expand recycled water use within north San Diego County to meet the region's future water needs, while minimizing the discharge of treated wastewater to the ocean. The Board of Directors directed the General Manager to work with Director Roberts and City Manager David Ott to better understand the strategy for pursuing federal grant funding, then return the item to the full Board of Directors for further discussion.

The General Manager reported that a conference call was conducted with the Hal Furman to discuss the current political climate in Washington D.C. and to review strategies for seeking grant funding for this project. Overall, Mr. Furman noted that regional infrastructure projects, be it freeways or water projects, will likely have the greatest probability for funding, if not in this fiscal year, then in future years.

From the information learned by Director Roberts, City Manager Ott, and General Manager Thornton, it was agreed that the SEJPA could benefit from the participation in this regional project and funding effort.

The General Manager stated that the annual total cost for the cost sharing agreement would be equally divided among the participating agencies. Staff estimates that the one-year cost of this agreement to the SEJPA is likely \$12,000 to \$14,000 and these funds are available in the Recycled Water Program Budget. This agreement would not obligate the SEJPA to participate for more than the current year, but multiple years of

lobbying will likely be required to obtain grant funding. The project has qualified for \$1.5 million in Proposition 84 grant funding to develop planning and engineering documents.

County Storm Water Management Agency and their flood control district, saying that channeled flood waters are a point source and must be treated before discharge to waters of the U.S.

DISCUSSION

Monthly Treatment Plant Performance and Evaluation

Wastewater treatment for the San Elijo Joint Powers Authority (SEJPA) met all NPDES ocean effluent limitation requirements for the month of February 2011. The primary indicators of treatment performance include the removal of Carbonaceous Biochemical Oxygen Demand (CBOD) and Total Suspended Solids (TSS). The SEJPA is required to remove a minimum of 85 percent of the CBOD and TSS from the wastewater. Treatment levels for CBOD and TSS were 93.9 percent and 91.5 percent, respectively, for February (as shown in Figure 1 and Figure 2).

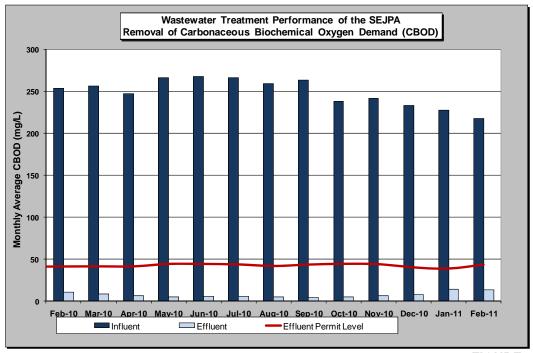

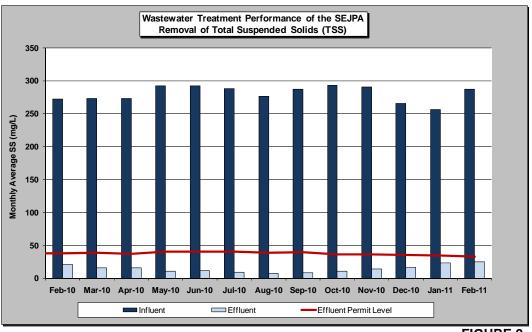

Table 1 (attached) presents the historical average, maximum, and unit influent and effluent flow rates per month for each of the Member Agencies. It also presents the number of connected Equivalent Dwelling Units (EDUs) for each of the Member Agencies during this same time period.

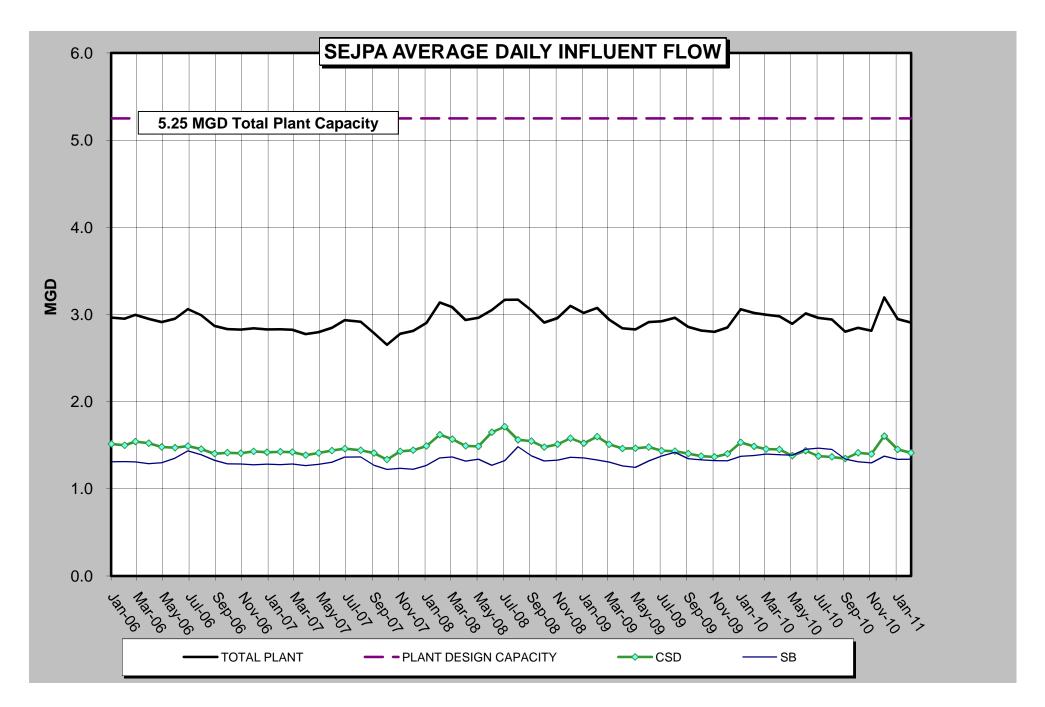
Figure 3: Average Daily Flow

Figure 3 (attached) presents the historical average daily flows per month for each Member Agency. This is to provide a historical overview of the average treated flow by each agency. As shown in the figure, the average treated flow typically ranges between 2.9 and 3.1 million gallons per day (mgd). Also shown in Figure 3 is the total wastewater treatment capacity of the plant, 5.25 mgd, of which each Member Agency has the right to 2.5 mgd, and Rancho Santa Fe Community Service District has the right to 0.25 mgd.

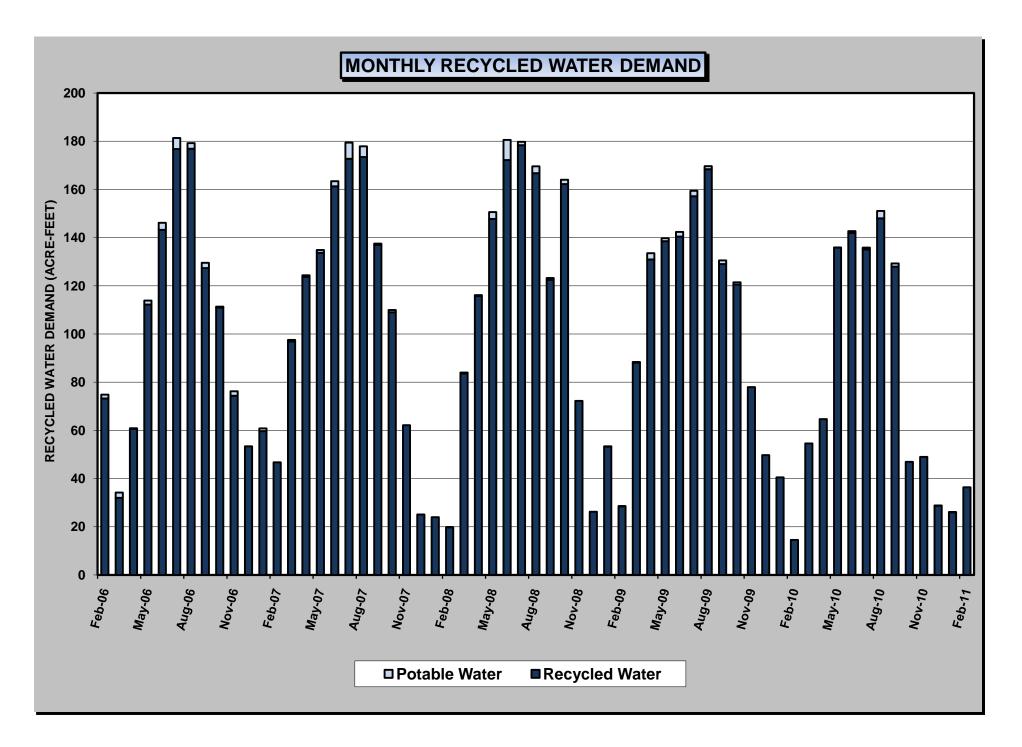
Recycled Water Production

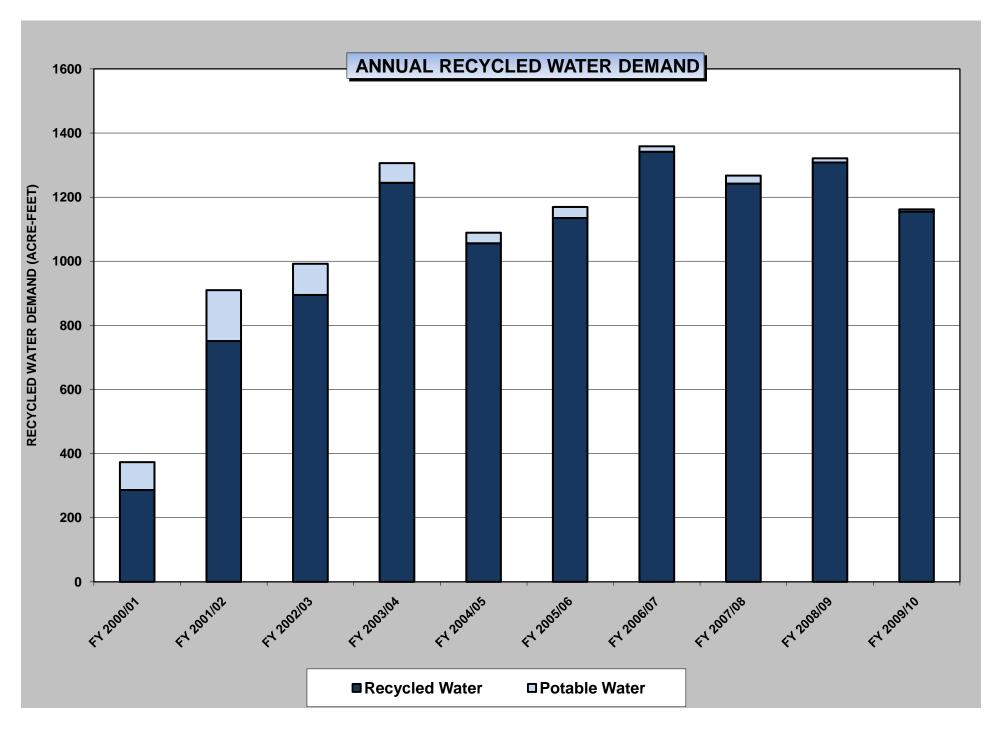
For the month of February 2011, recycled water demand was 36.34 acre-feet (AF), which was met using 36.34 AF of recycled water and 0.00 AF of supplementation with potable water. This equates to a blend mix for February of 100.0 percent recycled water and 0.0 percent potable water supplementation. Figure 1 (attached) provides monthly supply demands for recycled water over the last five years. Figure 2 (attached) provides a graphical view of annual recycled water demand spanning the last ten fiscal years. Recycled water demand can fluctuate from year to year, which is typically a function of weather. For example, Fiscal Year 2003-04, an unusually dry year, resulted in increased recycled water demand; and Fiscal Year 2004-05, an unusually wet year, resulted in lower recycled water demand.

FISCAL YEAR 2011-12 RECOMMENDED BUDGET

RECOMMENDATION

It is recommended that the Board of Directors:

- Review the Fiscal Year 2011-12 Recommended Budget and direct Member Agency Managers to take the recommended budget to their respective Councils for further discussion and support; and
- 2. Discuss and take action as appropriate.

DISCUSSION

The Fiscal Year (FY) 2011-12 San Elijo Joint Powers Authority (SEJPA) Recommended Budget has been prepared in accordance with the SEJPA formation agreement and the SEJPA's existing service agreements with other government entities. The budget estimates all expenditures necessary to provide wastewater treatment, waste disposal, water reclamation, laboratory, ocean outfall, and pump station services.

The total recommended Fiscal Year (FY) 2011-12 operating budget for the Wastewater Treatment Fund (which includes operations and maintenance for wastewater, laboratory, outfall, and pump stations, as well as bond debt for the 2003 Revenue bonds and the CEC loan) for the SEJPA is \$5,641,616, a 0.7 percent increase from a year ago. Revenues to support the Wastewater Treatment Fund come from the users of the provided services. The total recommended FY 2011-12 operating budget for the Water Reclamation Fund (which includes operations and maintenance, as well as debt service expenses) is \$1,826,025, a 0.9 percent increase from a year ago. Water Reclamation Fund revenues come from the sale of recycled water. The FY 2011-12 appropriation for the Capital Project Fund is \$942,000, up from \$670,000 and is funded based on ownership or leased capacity of the facilities being improved or constructed.

The proposed operations budget, which includes services for the Member Agencies, the cities of Del Mar and Escondido, the San Dieguito Water District and Santa Fe Irrigation

District, and the Rancho Santa Fe Community Service Districts, will increase by approximately \$53,400, or 1.1 percent. These are the day to day costs of operating and maintaining the facilities managed by the SEJPA and exclude debt service and capital projects.

SEJPA management has reviewed in detail all aspects of operations to trim costs without impacting the agency's ability to perform the vital functions it is tasked to do. The two largest programs, Wastewater Treatment, and Recycled Water, increased 1.4 percent and 1.7 percent respectively. The Laboratory Program, Outfall Program and the Cardiff Pump stations had decreases in their operating budget, while the other programs had increases in their budgets. When capital project funding and debt service are added to this, the services provided to the Cities of Encinitas and Solana Beach are proposed to increase 3.7 percent and 4.9 percent, respectively. The increase is due primarily to increased funding for the Capital Improvement Program (CIP).

The cost for wastewater treatment and disposal services borne by the ratepayers of the Member Agencies are allocated based on use, indicated by measured flows or level of effort, as appropriate. Flows are averaged over a 12 month period and vary from year to year, impacting the level of participation for each agency. On the basis of 15,940 connected equivalent dwelling units (EDU's) through December 2010, the services provided to the Member Agencies by the SEJPA for wastewater treatment and disposal will cost an average of \$160.67 per EDU. This represents an increase of 0.7 percent from a year ago. In historic terms, the proposed EDU rate reflects an annualized increase of *less than 1.5 percent* since the facility was upgraded to secondary treatment nineteen years ago (average EDU rate was \$127 in Fiscal Year 1993-94).

Contingency funding for each program area has been reviewed and budgeted on the basis of potential for unforeseen events within each program area. For all programs, the amount of contingency funding is \$160,590, a \$22,820 decrease from a year ago. This is a predetermined percentage of each program's supplies and services budget.

The Water Reclamation Program has completed its tenth full year of recycled water sales. Water sales revenues are expected to decrease approximately 9.7 percent from the current fiscal year. It is anticipated that sales volume will be about 1,000 acre-feet (AF) in the upcoming fiscal year. The program is projected to generate \$1.97 million in recycled water revenues for FY 2011-12. Expenses are projected to be \$1.83 million, which includes the \$834,675 loan payment to the State Revolving Fund.

The SEJPA Capital Improvement Program includes both new and ongoing projects for improvements to the wastewater treatment, ocean outfall, pumping stations, and the water reclamation programs. For the wastewater treatment program, capital projects include (1) the construction of electrical system upgrades, which include replacing outdated electrical equipment and emergency power systems; (2) Headworks and Grit Chamber Rehabilitation Project, (3) Biosolids Upgrade Reserve, and (4) the replacement of an existing 125 hp aeration blower. For the Moonlight Beach Pump Station, funding is being requested from the Encinitas Sanitary Division to repair and epoxy coat the walls and stairs in the pump station. Funding is being requested for the Ocean Outfall Program to develop and implement peak flow management solutions. Lastly, funding is being requested to complete the Sediment Drying Pad Project at the north end of the SEJPA property.

For FY 2011-12, bond debt service on the 2003 Revenue Bonds is \$1,571,700 with an interest rate of 4.6 percent. The annual State Revolving Fund (SRF) loan payment is \$834,675, with an interest rate of 2.5 percent. The loan with the State of California Energy Resources Conservation and Development Commission (CEC) is \$128,476, with an interest rate of 3.95%. As a result of minor increases to the bond rate, the overall change in debt service is an increase of 0.2 percent.

All issues related to the FY 2011-12 recommended budget are discussed in detail in the budget document, along with information regarding the contribution requirements of the various agencies served by the SEJPA.

<u>SUMMARY</u>

The total recommended FY 2011-12 operating budget for the Wastewater Treatment Fund for the SEJPA is \$5,641,616, which is a 0.7 percent increase from a year ago. Revenues to support the Wastewater Treatment Fund come from the users of the provided services. The total recommended FY 2011-12 operating budget for the Water Reclamation Fund is \$1,826,025, which is a 0.9 percent increase from a year ago. Water Reclamation Fund revenues come from recycled water sales. The FY 2011-12 appropriation for the Capital Project Fund is \$942,000, which will fund construction activities associated with upgrading the San Elijo Water Reclamation Facility electrical system, Headworks and Grit Chamber Rehabilitation project, a blower replacement project, additional funding to the Ocean Outfall Peak Management Project, completion of the Sediment Drying Pad project, and continued funding for the biosolids facility upgrade reserve.

The budget document has been prepared to provide detailed information regarding each program and the cost of services to the Member Agencies and other contracted service recipients.

It is therefore recommended that the Board of Directors:

- 1. Review the Fiscal Year 2011-12 Recommended Budget and direct Member Agency Managers to take the recommended budget to their respective Councils for further discussion and support; and
- 2. Discuss and take action as appropriate.
